



WHO WE ARE

Clermont Community Services is the Community Action Agency of Clermont County. We support the delivery of services that address essential health, housing and prevention needs with an emphasis on children and families with low to moderate income.

MISSION STATEMENT

Clermont Community Services provides essential services to its clients to assist them in reaching self sufficiency and improving their quality of life.



SERVICES

HEAP is a winter heating and summer cooling program assisting households with a one time emergency payment. You must meet Federal Income guidelines and provide required documents to qualify for vouchers including oil, propane, wood, gas and electric.

Youth Services - Drug prevention programs are offered in Clermont and Brown County schools. With support from United Way, this program is making an impact on our youth by building self esteem, refusal skills, drug prevention and conflict management.

The James Sauls Homeless Shelter provides emergency shelter care for residents of Clermont County. The shelter is open year round and is supported through United Way, federal funding and numerous volunteers and donations throughout the community.

EITC (earned income tax credit) program provides free tax preparation with electronic filing for income eligible clients.

HCRP (homeless crisis response program) provides rent assistance for income eligible clients exiting the homeless shelter and persons in danger of evictions.

Duke Energy Maintenance Service provides energy conservation and safety measures to eligible households in Clermont county. The programs can include furnace replacement, clean and tune of furnaces, wrapping of water tanks, installation of CFL light bulbs, smoke detectors and CO monitors.

The Pediatric Medical program provides comprehensive medical care to patients of Clermont and surrounding counties. The program focuses on providing a medical home for patients while providing well child and acute care.



The Pediatric Dental program provides comprehensive dental care to patients of Clermont and surrounding counties. The program provides preventative and restorative care regardless of income.

Weatherization is an energy conservation program available to income qualifying citizens of Clermont County that own or rent their homes. It is designed to help residents use less energy while increasing the comfort and safety of their home. Services can include the following: insulation of attics and floors, safety inspection and tune-up/repair of heating unit, reduction of air leakage from major sources, insulation of water tanks and heating ducts.
